- Item #1 – Notary Name Stamp and Embossed Seal (to be used with ink pad) (\$46.75 + \$2.65 tax) = \$49.40
- Item #2 – Notary Self-Ink Stamp with Seal (includes name stamp & notary seal in one) . (\$42.50 + \$2.37 tax) = \$44.87
- Item #3 – Notary Self-Ink Stamp without Seal (name stamp only in self-ink) (\$37.00 + \$2.02 tax) = \$39.02
- Item #4 – Notary Pre-Ink Stamp with Seal (includes name stamp & notary seal in one) . (\$44.75 + \$2.52 tax) = \$47.27
- Item #5 – Notary Pre-Ink Stamp without Seal (name stamp only in pre-ink) (\$37.85 + \$2.07 tax) = \$39.92
- Item #6 – Notary Name Stamp Only (to be used with ink pad) (\$24.40 + \$1.20 tax) = \$25.60
- Item #7 – Embossed Seal Only (\$33.70 + \$1.80 tax) = \$35.50
- Item #8 – Felt Stamp Pad Black Ink (\$11.35 + \$0.35 tax) = \$11.70

Price includes 6.50% Sales Tax and shipping charges.

If you do not wish to purchase these items from the Bar Association, you may purchase stamps and supplies from any stamp company or local stationery store.
